between 8:00 am up to 5:00 pm, which shall include but are not limited to the following required documents:

- Original or Certified True Copy of Bureau of Internal Revenue Certificate of Registration
 - Original or Certified True Copy of the latest income Tax and/or business Tax Return duly stamped "RECEIVED" by the Bureau of Internal Revenue, with validated tax payment made on the latest Income Tax Return. (BIR Form 2303 if it is a new corporation)
 - Original or Certified True Copy of the latest or updated Business Permit, with official receipt of payment
 - Original or Certified True Copy of the Certificate of Registration (Securities and Exchange Commission, Department of Trade and Industry, Cooperative Development Authority);
 - Original or Certified True Copy of the Valid Community Tax Certificate of the Bidder.
2. Two (2) Government Identification Cards of the bidder and the authorized representative of the bidder.
3. Special Power of Attorney/ Notarized Partnership Resolution/ Board Resolution and Secretary's Certificate authorizing the representative of the Bidder to act for and in behalf of the Bidder and to specifically perform the following acts:
- to register the Bidder on **27 August 2021**
 - to participate in the auction on **31 August 2021** in the Port of Cebu
 - submit the necessary documents
 - post the necessary bond
 - execute documents pertinent to this auction

4. Any new, additional, supplemental or remedial paper/ document shall no longer be accepted after the aforementioned deadline.
5. The conduct of the Public Auction Sale shall be subject to the following safety measures:
- Qualified bidders shall strictly observe social distancing
 - Only the qualified bidder and one companion shall be allowed inside the designated place for the public auction
 - Wearing of face masks and face shields is mandatory.
 - Body temperature of all qualified bidders and their companions shall be screened.
 - All participants shall at all time maintain proper and professional decorum.

6. The Auction Committee by a vote of simple majority, may disqualify any bidder or companion from participating in the Public Auction, who violates the aforementioned conditions and/or disrupt the proceedings. The disqualified bidder or companion shall be removed from the premises.
7. Payment of Php 5,000.00 Registration Fee, and legal research fee of Php 50.00. (non-refundable).
8. Posting of a duly receipted bond upon registration shall be made no later than **27 August 2021 at 5:00 pm**, in cash or manager's check in an amount equivalent to:

9. At the end of the bidding, the highest bidder shall be required to pay on cash/ manager's check equivalent to fifty percent (50%) of the bid price "ON THE SPOT" upon announcement of the winning bid on top of the bond in cash or manager's check as required in the immediately preceding paragraph. The remaining balance shall be paid on the succeeding business day. Failure to make any of the payments as required shall disqualify the bidder from participating further in the auction sale and the negotiated sale thereof, if applicable. This is without prejudice to the forfeiture of the cash bond and other payments made and the imposition of other sanctions as may be warranted.
10. The auction shall be conducted through sealed bids, which shall be submitted and opened in public by the Auction Committee at a time, date and place specified in the Notice of Auction Sale.
11. The highest bid shall be declared as the winner except when clustering occurs. Clustering occurs when the difference between the highest and second highest bid is within the ten percent (10%) of the highest bid. In such case, an open bidding shall be conducted among the bidders of the particular sale lot who are present with the highest bid serving as the new floor price. Only bids raised by three percent (3%), more than the new floor price shall be considered and the highest bid in the open bidding shall be declared as the winner. Otherwise, the highest sealed bid shall be declared as the winner.
12. A failed bidding shall be declared by the Auction Committee when any of the following circumstances occurs:
 - When there is only one sealed bid, the same shall not be opened.
 - When there are two sealed bids but there is only one bid higher than the floor price.
 - When there is no bid.

- When the highest bidder fails to comply with any of the payments required under Section 5.10 of CAO 03-2020, said bidder shall be disqualified from participating further in the public auction.
13. Non-compliance with any of the terms and conditions of the Notice of Public Auction shall result in the forfeiture of any payments made by the winning bidder without prejudice to the forfeiture of the subject shipments in favor of the government.
 14. The winning bidder shall withdraw in full the total quantity of the shipment as indicated in the Notice of Award in five (5) working days. Otherwise, a storage fee based on existing rates shall be imposed/ charged according to CMO 59-90.
 15. Payment with Manager's Check to the Bureau of Customs, District Port of Cebu (BOC, POC) shall bear:
 - a. Pay to: **BOC FAO Bidder Name**.
 16. When the winning bidder fails to claim the items or lots awarded to him within thirty (30) calendar days from the date of award, upon DUE NOTICE, he shall be deemed to have abandoned said goods and to have renounced all his rights thereto including forfeiture of all payments made thereon, except upon justifiable reason, as determined by the District Collector, upon recommendation of the Auction Committee.
 17. The Bureau of Customs, District Port of Cebu, reserves the right to ensure that only those who have complied with the herein enumerated requirements shall register and participate in the public auction.
