Anent the above-mentioned subject, a stripping was conducted together with the representatives from CIIS, ESS, X-ray Division, District Collector's Office on two containers said to contain the **PERSONAL EFFECTS** of the consignee.

It was observed that some of the items were not declared in the packing list and in the Informal Import Declaration and Entry namely; 2 units used Chainsaw and 8 empty Magazine for M16 Rifle. Hence, in violation of Section 117 & Section 1401 of the CMTA in relation to the Comprehensive Firearm and AMMO Regulation Act.

The 2 units used Chainsaw and 8 empty magazine M16 Rifle were formally turned over on even date to the ESS, Property Custodian SAII Robert Terrence P. Monteño.

Premises considered, issuance of an Alert Order is recommended.
