## **DESCRIPTIVE REPORT**WEEKLY REPORT for January 21-25, 2019

Port of Clark has recorded 31 formal entries, 1,960 transshipment entries, 5 warehousing entries, 82 informal entries and 1,039 export entries which were filed and completed this week, gathering a total of 3,117 entries.

There are no reports on auction within the week. However, there were two (2) Warrants of Seizure and Detention issued for two (2) shipments found to contain a total of 1,834 grams of Methamphetamine Hydrochloride with an estimated value of P12 Million.
