DESCRIPTIVE REPORT WEEKLY REPORT for January 22-26, 2018

Port of Clark has recorded 24 formal entries, 876transshipment entries, 44warehousing entries, 66informal entries and 959export entries which were filed and completed this week, gathering a total of 1,969entries.

There are no recorded reports onauctioned shipments. However, consecutive seizures of methamphetamine hydrochloride (shabu) were recorded for the week. The first seizure has an estimated weight of 6.4 kilosthat is worth 34 million pesos apprehended last January 23. Such contraband was turned over to PDEA last January 25. While the second shipment of shabu was seized last January 25 having an approximate weight of 18 kilos worth 90 million pesos.
