DESCRIPTIVE REPORT WEEKLY REPORT for January 29-February 2, 2018

Port of Clark has recorded 23 formal entries, 1,283transshipment entries, 44warehousing entries, 66informal entries and 1,145export entries which were filed and completed this week, gathering a total of 2,561entries.

There are no recorded reports onauctioned shipments, apprehensions and seizures for the week. However, the seized shipment of methamphetamine (shabu) worth 90M was already turned over to PDEA last January 30.
