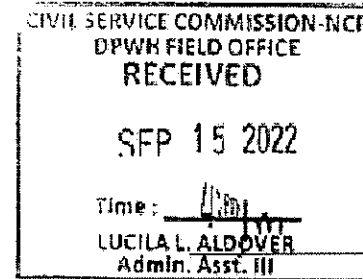

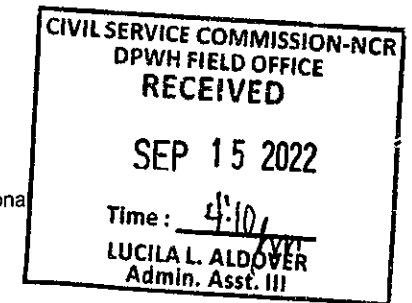

- 3.b. For positions not involving practice of profession: Copy of Certificate of Eligibility;

5. Certificate of Employment for BOC Contract of Service Personnel and External Applicants
