NOTICE TO FILE/LODGE GOODS DECLARATION, TO PAY DUTIES AND TAXES, AND TO CLAIM OVERSTAYING/ABANDONED GOODS AS OF JANUARY 12, 2021

This is to inform the following consignees whose shipment with Bill of Lading Numbers and Container Numbers indicated in the attached list is presently stored at the Port of Manila and has been deemed abandoned pursuant to Section 1129 of RA 10863 otherwise known as the Customs Modernization and Tariff Act (CMTA) *vis-à-vis* Joint Administrative Order (JAO) 20-01 for failure on the part of the consignee to file/lodge corresponding Goods Declaration, pay duties and taxes and/or claim goods.
