NARRATIVE REPORT

Week of October 27- November 2, 2017

For this week, the Collection District of Iloilo has a total of 40 entries which are composed of exports, formal and informal entries.

At the main port, there are seven (7) formal entries filed; one (1) entry was completed and six (6) entries are still in progress. 27 informal entries and (4) exports were filed and completed.

For the Sub-port of Pulupandan, two (2) formal entries were filed and completed. No informal entries and exports were filed for this week.

There are no operational highlights for this week. Also, there are no reports for balikbayan boxes, auctions, alert orders, apprehensions, warrant of seizure and detention.
