### **Weekly Report to PIAD**

#### **Brief Narrative** *(April 15-19, 2019)*

For the period *April 15-19, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of five (5) entries: one (1) filed, one (1) in-progress and one (1) completed under formal entry; one (1) completed export entry; and one (1) completed formal entry

The total duties and taxes collected amounted to **Php13,700,182.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
