Brief Narrative (April 22-26 2019)

For the period *April 22-26, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of six (6) entries: two (2) filed and one (1) completed under formal entry; and three (3) completed export entry.

The total duties and taxes collected amounted to **Php39,111,418.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
