### **Weekly Report to PIAD**

#### **Brief Narrative** (*August 5-9, 2019*)

For the period *August 5-9, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of three (3) entries, two (2) in-progress under formal entry and one (1) completed export entry.

The total duties and taxes collected amounted to **Php8,905,859.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
