Brief Narrative (January 13-17, 2020)

For the period *January 13-17, 2020*, Bureau of Customs, Port of Legazpi, had recorded two (2) entries: one completed formal entry and one completed export entry.

The total duties and taxes collected amounted to **Php26,603,452.00** for January 1-17, 2020.
