## **Weekly Report to PIAD**

**Brief Narrative** (January 20-24, 2020)

For the period *January 20-24, 2020*, Bureau of Customs, Port of Legazpi, had recorded one completed formal entry.

The total duties and taxes collected amounted to **Php60,539,100.00** for January 1-24, 2020, hitting the collection target of Php50,000,000.00 for the month of January 2020.
