

Brief Narrative (April 29- May 3, 2019)

For the period *April 29- May 3, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of five (5) entries: two (2) filed and two (2) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php39,114,758.00**, hitting the collection target of Php31,990,000.00 for the month of April 2019.
