

## **Weekly Report to PIAD**

Brief Narrative (March 25-29, 2019)

For the period *March 25-29, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of six (6) entries: four (4) filed and one (1) in-progress under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php44,783,059.12**, hitting the collection target of Php40,780,000.00 for the month of March 2019.
