

Weekly Report to PIAD

Brief Narrative (March 18-22, 2019)

For the period *March 18-22, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of eight (8) entries: four (4) filed, one (1) in-progress and one (1) completed under formal entry; and two (2) completed informal entries.

The total duties and taxes collected amounted to **Php37,444,546.80.** Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
