

Weekly Report to PIAD

Brief Narrative (March 4-8, 2019)

For the period *March 4-8, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of eight (8) entries: one (1) filed, three (3) in-progress and two (2) completed under formal entry; one (1) completed export entry; and one (1) completed postal entry.

The total duties and taxes collected amounted to **Php18,865,499.** However, other formal entries are now being processed for final assessment once the discharge operations are done.
