

Weekly Report to PIAD

Brief Narrative (May 13-17, 2019)

For the period *May 13-17, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of six (6) entries: two (2) filed, one (1) in-progress and one (1) completed under formal entry; one (1) completed informal entry and one (1) completed export entry.

The total duties and taxes collected amounted to **Php63,817,277.00.** Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
