#### **Brief Narrative** *(May 27-31, 2019)*

For the period *May 27-31, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of three (3) entries: two (2) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php129,531,103.00**, hitting the collection target of Php40,700,000.00 for the month of May 2019.
