

Brief Narrative (May 6-10, 2019)

For the period *May 6-10, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of three (3) entries: two (2) in-progress under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php2,298,078.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
