## **Weekly Report to PIAD**

### **Brief Narrative** *(November 11-15, 2019)*

For the period *November 11-15, 2019*, Bureau of Customs, Port of Legazpi, had recorded two (2) completed export entries.

The total duties and taxes collected amounted to **Php5,669,916.00** as of November 1-15, 2019 from one (1) formal entry last week.

#### **Significant Events/Activities:**

On November 15, 2019, Acting District Collector Alexander M. Go, MMBM, together with SP/LT Alan Diancin attended the Maritime Security Forum 2019 at Legazpi City. The forum was to strengthen the collaboration among maritime stakeholders with an end goal to secure the maritime domain of the region.
