## **Weekly Report to PIAD**

**Brief Narrative** (September 23-27, 2019)

For the period *September 23-27, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of five (5) entries: two (2) files, one (1) in-progress and one (1) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php6,895,415.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
