Weekly Report to PIAD

Brief Narrative *(September 30-October 4, 2019)*

For the period *September 30-October 4, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of six (6) entries: one (1) filed and three (3) completed under formal entry; and two (2) completed export entries.

The total duties and taxes collected amounted to **Php5,580,938.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
