

Weekly Report to PIAD

Brief Narrative (August 26-30, 2019)

For the period *August 26-30, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of nine (9) entries: one (1) in-progress and six (6) completed under formal entry; one (1) completed informal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php35,942,558.00**, hitting the collection target of Php35,601,792.00 for the month of August 2019.
