### **Weekly Report to PIAD**

#### **Brief Narrative (*July 1-5, 2019*)**

For the period *July 1-5, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of four (4) entries: two (2) filed and one (1) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php5,571,733.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
