

### **Weekly Report to PIAD**

#### **Brief Narrative** *(July 15-19, 2019)*

For the period *July 15-19, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of two (2) entries: one (1) filed and one (1) completed under formal entry.

The total duties and taxes collected amounted to **Php28,471,411.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
