Brief Narrative (July 8-12, 2019)

For the period *July 8-12, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of four (4) entries: one (1) filed and two (2) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php26,015,420.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
