Brief Narrative *(June 17-21, 2019)*

For the period *June 17-21, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of six (6) entries: one (1) filed, two (2) in-progress and two (2) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php51,177,576.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
