

## **Weekly Report to PIAD**

Brief Narrative (June 24-28, 2019)

For the period *June 24-28, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of six (6) entries: two (2) filed and three (3) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php70,797,931.00**, hitting the collection target of Php30,530,000.00 for the month of June 2019.
