Brief Narrative *(June 10-14, 2019)*

For the period *June 10-14, 2019*, Bureau of Customs, Port of Legazpi, had recorded a total of six (6) entries: four (4) filed and one (1) completed under formal entry; and one (1) completed export entry.

The total duties and taxes collected amounted to **Php16,132,653.00**. Further, other formal entries shall be processed for final assessment once the discharge operations are completed.
