1,900,000 kilograms, and the winning bidder wishes to acquire the excess, he would have to pay a total of 50,747,863.25. the total amount has been arrived at by using the aforesaid formula, thus:

Total Amount to be Paid = $\frac{\text{PhP}50,000.00 \times 1,900,000 \text{ kgs.}}{1,872,000}$

a.2. should the winning bidder decide to purchase the excess weight, he shall pay the amount for the excess weight within five (5) days from demand thereof by the District Collector, or his duty authorized representative; otherwise, the excess quantity shall not be considered to have been sold and shall be offered for in the next public auction of the port.

15.
