It was late afternoon on the 8th of June 2017, when the subject shipment has been 100% examined in relation with the X-Ray Inspection Report submitted by the Team of **MR. ROBERT QUINTANA**, Head Non-Intrusive Inspection Unit from the office of the **COLL. EDGAR Z. MACABEO**, District Collector, Ninoy Aquino International Airport dated 19 May 2017. During X-ray inspection, the subject parcel has been suspected to contain "GUN PARTS/ACCESSORIES and AMMO RELOADING EQUIPMENT", and therefore a 100% examination and verification of pertinent documents has been requested.

Inventory conducted revealed that the subject parcel consigned to *Grace Soriano* and declared as "Metal handle, Plastic Tubes, and Screws & Bolts" contain "**Parts and Accessories of gun**" with assessed value of **Php 208,826.96** (US \$ 4,171.20, ex rate – Php 50.064) instead.
