## Terms and Conditions of Public Auction:

The Conduct of the Public Auction shall made through On-Line System.

- The On-line filing and submission of Bidder's Registration Form with the required documents shall made at least two (2) days prior to the day of Auction. Thereafter the On-Line Registration will be closed. Submissions after the cut-off date, will no longer be accepted.
- Along with the registration form, interested participants, whether natural or juridical, shall submit the following on-line:
  - a.) Certified True Copy of the Business Permit from the issuing LGU with Official Receipt
  - b.) Certified True Copy of the DTI Registration with Official Receipt (For Single Proprietorship Business)
  - c.) Certified True Copy of the Certificate and Articles of Incorporation with Official Receipt (For Corporations)
  - d.) Certified True Copy of Income and/or Business Tax Returns duly stamped and received by the Bureau of Internal Revenue (BIR) with a validated tax payment made thereon.
  - e.) Scanned Copy of the BOC Official Receipt evidencing payment of Php 5,050.00 Registration Fee (non-refundable).
  - Valid government issued ID of the participant who will actually participate in the Auction.
  - g.) BOC Official Receipt of Registration
  - h.) BOC Official Receipt of the 20% Bond Posted in a particular lot offered for auction.
  - i.) For corporate and partnership participants, only the incorporators or officers or employees or partners are allowed to represent the company/partnership accompanied with the duly issued Board Resolution or Secretaries Certificate. Non-officers and employees or partners are not allowed to represent the company/partnership.
  - Single proprietorships shall be represented by the owner. No proxies or authorized representatives are allowed.

- k.) The Interested auction participant shall indicate in the Bidders Registration Form the specific lot numbers they are interested to participate.
- Only those participants who will be able to comply with the foregoing requirements shall be allowed to participate in the On-line Auction.
- Posting of duly receipted bond in cash or manager's check in an amount equivalent to twenty percent (20%) of the floor price for each sale lot. The bond shall be refunded to the losing bidder after the closing of the auction. The bond shall not, however, be required when the floor price of a sale lot is less than ten thousand pesos (P 10,000.00).
- 6. Since the Auction is conducted on line Via zoom, all qualified bidders shall submit/tender their bids via online to a designated email account, which shall be provided by the Secretariat on the day of the Auction. The highest bid shall declared as the winner except when clustering occurs. Clustering occurs when the difference between the highest and the second highest bid is within ten percent (10%) of the highest bid. In such cases, an open bidding shall be conducted among the bidders of the particular sale lot who are present with the highest bid serving as the new floor price. Only bids raised by three percent (3%) more than the new floor price shall be considered the highest bid in the open bidding shall be declared as the winner. Otherwise, the highest sealed bid shall be declared as the winner. Payment of highest bidder in cash or manager's check at least fifty percent (50%) of the bid price on the spot upon announcement of the winning bid as duly certified to by the Auction Committee and the COA representative. The remaining balance shall be paid on the succeeding business day.
- Payments of highest bidder in cash or manager's check at least fifty percent (50%) of the bid price on the spot upon announcement of the winning bid as duly certified to by the Auction Committee and the COA representative. The remaining balance shall be paid on the succeeding business day.
- Payments with Cashier's/ Manager's Check/ Cash to the BOC/CDO shall bear the following:

## BTR FAO IFO (PAYOR'S NAME)

- A failed bidding shall be declared by the Auction Committee when any of the following circumstances occurs:
  - a. When there is only one on-line bid submitted, the same shall not be read.
  - When there are two sealed bids but there is only one bid higher than the floor price.
  - c. When highest bidder fails to comply with any of the payments required in Section 8 hereof, said bidder shall be disqualified from participating further in the auction sale and when applicable, the negotiated sale thereof without prejudice to the forfeiture of the cash bond and any payment made and imposition of other sanctions as may be warranted.
- 10. When a failed bidding is declared, the sale lot shall be offered in a second auction to be held on the third business day after the first failed auction at the same floor price without need of further advertisement/posting. In case of perishable goods, the second auction shall be conducted on the first business day following the first failed bidding.
- 11. Any bids tendered in any lot offered for sale during the conduct of the auction below the minimum floor price set in the Notice of Public Auction will merit the automatic forfeiture of the cash bond in favor of the government as posted by the bidder on that particular lot where the bid was tendered.
