DECREE OF ABANDONMENT

WHEREAS, on 17 June 2020, the Committee on Condemnation issued the Orders of Condemnation to the shipments that were forfeited/abandoned in favor of the government pursuant to Section 1113 (I) and Section 118 of the CMTA, in relation to R.A. 8293 "The Intellectual Property Code of the Philippines", R.A. 9711 "FDA Act of 2009", and R.A. 4653 laws, rules and regulations. The said shipments ordered for condemnation was awarded to JONCYR Enterprises Inc.

WHEREAS, on 19 June 2020, the Auction and Cargo Disposal Division (ACDD) issued two (2) Gatepasses for Orders of Condemnation to the various shipments, however, some of the container vans in the said Gatepasses were not immediately released due to lack of Container Release Orders (CROs) issued by the corresponding shipping lines including the three (3) containers bearing Container Van Nos. FSCU6531805, GESU5815762 and CAXU9947431;

WHEREAS, on 22 October 2020, the District Collector requested the Asian Terminals Inc., to release the overstaying container vans without CRO's since the corresponding shipping lines are no longer in existence or no longer doing business in the Philippines;

WHEREAS, the container van bearing No. FSCU6531805 under Gatepass No. 00015434 and Container Van Nos. GESU5815763 and CAXU9947431 under Gatepass No. 00015425 was released without the prerequisite CRO after JONCYR Enterprises executed an Affidavit of Undertaking for Safekeeping of the said container van. Thus, the JONCYR Enterprises Inc. has three (3) container vans for safekeeping in their facility;

WHEREAS, on 03 February 2021, Atty. Enrico A. Turingan III, Chief, ACDD, requested the issuance of Decree of Abandonment for the Three (3) empty containers for proper disposition of the same;

WHEREAS, on 23 February 2021, a Final Notice of Overstaying Containers was posted at the Bureau of Customs Website with the information that "Five (5) days upon posting of the same at the Bulleting Board of the Port of Manila and BOC website the said containers will be declared abandoned by the District Collector and accordingly will be issued Decrees of Abandonment pursuant to the provisions of the CMTA";

WHEREAS, it can be presumed that the three (3) Empty Containers located at JONCYR Enterprises Inc. whose shipping lines are no longer in existence to issue CRO's are abandoned pursuant to Section 1129 of the CMTA;



WHEREFORE, by virtue of the authority vested in me by law, the Three (3) Empty Containers bearing Container Van Nos. FSCU6531805, GESU5815763, and CAXU9947431, located at JONCYR Enterprises Inc., are hereby declared ABANDONED in favor of the government to be disposed of in the manner provided for by law.

Let copies of this Decree of Abandonment be furnished to all parties and offices concerned for their information and guidance.

NOTICE OF OVERSTAYING EMPTY CONTAINERS WHOSE SHIPPING LINES ARE NO LONGER IN EXISTENCE OR DOING BUSINESS IN THE PHILIPPINES

Pursuant to Section 1129 of the Customs Modernization and Tariff Act (CMTA) and CMO No. 16-2019 on Guidelines on the sending of Notice under the same, let this be a Final Notice to all owners of overstaying empty containers stored at JONCYR ENTERPRISES INC.

Five (5) days upon posting of the same at the BOC website the said containers will be declared abandoned by the District Collector and accordingly will be issued Decrees of Abandonment pursuant to the provisions of the CMTA. Port of Manila. Philippines, 22 February 2021.
