NOTICE OF SALE

Pursuant to the provisions of Section 2601 to 2610 of the Tariff and Customs Code of the Philippines, as amended, in relation to CAO 10-2007 dated November 28, 2007 and other relevant Customs Memorandum Orders, there shall be a Public Sale through Sealed Bidding to be conducted by the Auction and Cargo Disposal Unit, Port of Clark international Airport on:

Date of Public Auction : **September 04, 2017**
 Opening of Sealed Bids : 9:30 AM
 Place : Conference Room, Bureau of Customs, Clark Freeport Zone, Pampanga

Public viewing of the lots subject for auction and Pre-Bid Conference for all qualified bidders will be on **August 31 and September 01 at 2:00 PM.**

In the event of failed bidding, the second public sale shall automatically be on the third business day following the first bidding (December 28, 2016), at the same floor price without need of further publication/posting. When at least two of the sealed bids submitted in the public sale fall within a range of ten (10%) percent from the highest bid, the same being above the floor price, those in this "clustering" shall immediately go into an open bidding with the highest sealed bid serving as the new floor price of the lot being sold. In such case, an open bidding shall be conducted among the bidders of a particular sale lot, who are present, with the highest bid serving as the new floor price. Only bids raised by three percent (3%) more than the new floor price shall be considered and the highest bid in the open bidding shall be declared as the winner. Otherwise, the highest sealed bid shall be declared the winner.

- Payment of non-refundable Php 2,020.00 Registration Fee
- Posting of a duly receipted bond in cash or manager's check in an amount equivalent to:

4. Registration with the **Acting Chief of Auction and Cargo Disposal Unit**, to be filled on or before the date of actual bidding; thereafter, registration is **closed**.
5. At the end of bidding, the highest bidder shall be required to pay in cash/ manager's check equivalent to fifty percent (50%) of the bid price "on the spot" upon the announcement of the winning bid on top of the bond as required in No. 3 hereof. The remaining balance shall be paid on the succeeding business day.
6. Payment with manager's check must be:
 - a. Pay to the order of the Bureau of Customs. Port of Clark
 - b. For the account of the winning bidder

The Bureau of Customs, District Port of Clark, reserves the right to ensure that only those who have complied with the herein enumerated requirement shall register and participate in the public sale.
