This is with reference to the request of the Joint Foreign Chambers of the Philippines regarding the current status and progress of the Philippine National Single Window (PNSW) System.

Attached herewith is the list of agencies complaint and non-compliant with the PNSW. Please note that some agencies completely or partially use the PNSW System; while some agencies still engages in the manual processing.

We wish to inform you that we are pushing for the immediate implementation of the PNSW Phase 2, as well as the Integrated Enhanced Customs Processing System. This will involve the addition of the non-compliant agencies to the NSW System. Currently, these projects are undergoing the bidding process at the Department of Budget and Management.

Rest assured that the Bureau of Customs, together with our partner agencies, will work together to continually advance the status of the PNSW System and to put the Philippine's stance at par with our neighbouring ASEAN countries.
