BRIEFER: 18-23 SEPTEMBER 2017 AT THE POM

In summary, the Port of Manila processed a total **6,791 Entries** - ranging from Transshipment, Warehousing, Export, Formal and Informal – generally for the **period of 18-23 September 2017**, among which 47 containers containing Balikbayan boxes were processed.

Three (3) Warrants of Seizure and Detention (WSD) were issued by the Law Division and there was no Alert Order issued and Auction for the said period.

On 18 September 2017, turn-over ceremony was held at the Port of Manila's Conference Room between Atty. Ma. Rhea M. Gregorio, outgoing Acting Port Collector, and Atty. Ernelito G. Aquino, new Officer-in-Charge of the Port of Manila, officiated by the Hon. Commissioner Isidro S. Lapeña, PhD, CSEE.

Holy Masses were celebrated at the POM Lobby on 20 and 22 September 2017.

Last 23 September 2017, the Port of Manila conducted its 7th Corporate Social Responsibility Activity at the Bahay Kalinga, Department of Social Welfare and Development District Office VI, Paco, Manila to more than 100 senior citizens received basic geriatric supplies.
