***BRIEFER: 28 AUGUST – 02 SEPTEMBER 2017 AT THE POM***

In summary, the Port of Manila processed a total of **7,296** Entries - ranging from Transshipment, Warehousing, Export, Formal and Informal – generally for the **period of 28 August – 01 September 2017**, among which 42 containers containing Balikbayan boxes were processed.

One (1) Warrant of Seizure and Detention (WSD) was issued by the Law Division. There were 6 lots auctioned for the said period but 3 lots resulted in a failed bidding.
