BRIEFER: 11-16 DECEMBER 2017 AT THE POM

In summary, the Port of Manila processed **8,701 Entries** - ranging from Transshipment, Warehousing, Export, Formal and Informal – generally for the **period of 11-16 December 2017**, among which 74 containers containing Balikbayan boxes were processed.

There were three (3) Warrant of Seizure issued and no Alert Order issued. There was no Auction and no new schedule for auction.

Back-to-Back Highest Monthly Collection

The Port of Manila (POM) posted back-to-back highest monthly collection in the

port's history. The first was in **October 2017** when it collected a record high of **7.10 billion**. But the October 2017 record high collection was surpassed not long after, specifically in **November 2017** the POM collected a new record high of **7.417 Billion**.
