***BRIEFER: 04-09 DECEMBER 2017 AT THE POM***

In summary, the Port of Manila processed **8,474 Entries** - ranging from Transshipment, Warehousing, Export, Formal and Informal – generally for the **period of 04 – 09 December 2017**, among which 78 containers containing Balikbayan boxes were processed.

There was one (1) Warrant of Seizure issued and no Alert Order issued. There was no Auction for the said period while there are five (5) lots scheduled for auction.

***POM's Status Verification System (SVS)***

The 3<sup>rd</sup> SVS kiosk has been deployed, bringing a total of three (3) SVS kiosk, two (2) at the POM lobby and another at the back door of the Social Hall.

***Holy Masses***

***POM Screensaver and GREEN LIGHT: POM Emergency Preparedness Programs***

On 08 December 2017, Part II of the POM Screensaver on instructional video in cases of emergency (*e.g. earthquake, fire, inclement weather*) is undergoing its final review and is tentatively scheduled to be downloaded next week.
