

## ***BRIEFER: 26-30 DECEMBER 2017 AT THE POM***

In summary, the Port of Manila processed **6,214 Entries** - ranging from Transshipment, Warehousing, Export, Formal and Informal – generally for the **period of 26-30 December 2017**, among which 59 containers containing Balikbayan boxes were processed.

There was one (1) Warrant of Seizure issued and no Alert Order issued. There was no Auction and no new schedule for auction.
