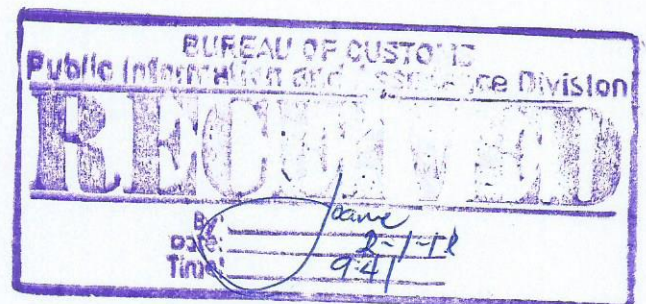

In summary, the Port of Manila processed **6,385 Entries** - ranging from Transshipment, Warehousing, Export, Formal and Informal – generally for the **period of 22-27 January 2018**, among which 40 containers containing Balikbayan boxes were processed.

There was one (1) Warrant of Seizure case that has pending decision under Law Division. There was no auction and no new schedule for auction for the said period.

Oath-taking of new Customs Operations Officer I (COOI) assigned at Ninoy Aquino International Airport (NAIA) led by Commissioner Isidro S. Lapeña during the flag raising ceremony last 22 January 2018 at the POM Grounds.
