NARRATIVE REPORT

Week of September 22-29, 2017

In the continuing support towards Civil Service Commission's implementation of quality service delivery of the government front liners, the port held a *Seminar on Integrity, Transparency and Accountability in Public Service*. Topics on Ethics, Integrity and Accountability in the bureaucracy were intensively and joyfully discussed by CSC accredited speaker *Mr. Jerome R. Eslabra* on September 29, 2017 at Assessment Division, Port of Iloilo.

For this week, the District of Iloilo has a total of 25 entries filed which are composed of exports, formal and informal entries.

At Port of Iloilo, four (4) entries were completed out of six (6) formal entries filed. Nine (9) informal entries and six (6) exports were filed and completed.
