



NOTICE OF PUBLIC AUCTION

Pursuant to Sections 1139 to 1151 of the Customs Modernization and Tariff Act, as amended, in relation to CAO No. 03-2020, CAO 10-2007, as amended by CAO 04-2016, and other relevant Customs Memorandum Orders, a second Public Auction Sale (the first one on November 4, 2020 having been declared a failed bidding for absence of a bid) on "As is Where Is" basis through Sealed Bidding shall be conducted by the Auction and Cargo Disposal Committee (ACDC), Port of Surigao on **WEDNESDAY, 11 NOVEMBER 2020** at the office of the District Collector, 2nd Floor Maria Conchita Bldg. Terms and Conditions of Public Auction:

1. Filing with this Port of the duly accomplished prescribed Registration Form, and submission of a certified true copy of the prospective bidder's latest Income and/or Business Tax Returns duly stamped and received by the Bureau of Internal Revenue and validated by payment made thereon. The filing and submission shall be made at the Bureau of Customs, Port of Surigao not later than two (2) days prior to the date of auction sale;
2. Payment of Php5,050.00 non-refundable Registration Fee;
3. Registered bidders shall indicate the following in the appropriate log book: a.) their name, b.) address, c.) TIN, and other relevant circumstances at least one (1) day before the date of actual bidding. Thereafter, registration is closed;
4. Posting of a bond in cash or manager's check in an amount fixed by CAO No. 04-2016 as indicated in the table below. An appropriate receipt for the amount of the bond shall be

issued, and the said amount shall be refunded to the losing bidder after the closing of the auction;

5. Deadline for the submission of the sealed bids shall be 9:00 in the morning of November 4, 2020. No bids shall be accepted after such deadline;
6. The highest bid shall be declared as the winner except in case of clustering. There is clustering when the difference between the highest and the second highest bid is within ten percent (10%) of the highest bid. In such a case, an open-bidding shall be conducted among all the bidders who participated in the Sale Lot with the highest bid serving as the new floor price. Only bids raised by three percent (3%) more than the new floor price shall be considered and the highest bid in the open-bidding shall be declared as the winner. Otherwise, the highest sealed bid shall be declared as the winner;
7. Full payment by winning bidder in cash or manager's check of the bid price less the amount of the bond posted upon announcement of the winning bid as duly certified to by the ACDC and COA representative. A Certificate of Award shall be given to the winning bidder upon full payment of the bid amount. Failure to pay in full shall cause the forfeiture of the deposit without prejudice to any sanction that the ACDC may impose;
8. Payments with Cashier's / Manager's Check / Cash to the BOC / Port of Surigao indicating the following:
 - a. Pay to the order of Land Bank of the Phils-Surigao City Branch,
 - b. For credit of the Bureau of Customs-Port of Surigao, and
 - c. For the account of _____, the bidder;
9. When the winning bidder fails to claim the items or lot awarded to him within thirty (30) calendar days from the date of award, upon due notice, he shall be deemed to have abandoned said goods and to have renounced all his rights thereto including forfeiture of all payments made thereon, except upon justifiable reasons, as determined by the District Collector, upon recommendation of the ACDC.
10. A failed bidding shall be declared by the ACDC when any of the following circumstances occurs:
 - a. When there is no bid; and
 - c. When the highest bidder fails to comply with any of the payments required in Section 5.10 CAO 03-2020, said bidder shall be disqualified from participating further in the public auction and when applicable, the negotiated sale involving the same without prejudice to the forfeiture of the minimum deposit and any payment made and imposition of other sanctions as may be warranted;
