WARRANT OF SEIZURE AND DETENTION

Greetings!

WHEREAS, on 14 August 2022, a shipment from Warszawa, Poland said to contain **"KABANOSY WIEPRZOWE ENJOY 105G"** consigned to a certain BARCODE RESTO BARS OPC arrived at the United Parcel Service (UPS) Clark Hub under House Airway Bill No. 1E46R4JH8MZ and the same was profiled for physical examination;

WHEREAS, on 21 August 2022, Acting Customs Examiner Fatima Jehanne Domadalug conducted physical examination on the subject shipment in which **eleven (11) boxes Assorted Sausages/Meat Products** were found;

WHEREAS, on 26 August 2022, Veterinary Quarantine Officer Francis G. Dimalanta of Bureau of Animal Industry (BAI), thru Notice of Violation No. 04309, recommended the confiscation of the said shipment due to African Swine Fever (ASF) banned country;


WHEREAS, on 23 November 2022, the Office of the District Collector received a Memorandum of even date from Mr. Ronaldo Aguirre and Ms. Domadalug, UPS Composite Unit Officer-In-Charge (OIC) and Acting Customs Examiner, respectively, thru Atty. Felipe Geoffrey De Vera IV, Deputy Collector for Assessment, recommending the issuance of a Warrant of Seizure and Detention (WSD) against the subject shipment for violation of Sections 117, 118 and 1113 (f), (i) and (l) of Republic Act (R.A.) No. 10863 otherwise known as the Customs Modernization and Tariff Act (CMTA) in relation to Department of Agriculture (DA) Administrative Order No. 9 Series of 2010;

WHEREAS, upon evaluation thereof, this office finds probable cause for the issuance of WSD against the subject shipment for violation of Sections 117, 118 and 1113 paragraphs (f) and (l) (5) of R.A. No. 10863 otherwise known as the CMTA in relation to DA Administrative Order No. 9 Series of 2010;

WHEREFORE, by virtue of the power vested in me by law, and in compliance with pertinent Customs law, rules and regulations, you are hereby ordered to forthwith seize the aforementioned articles and take custody over the same pending termination of the seizure and forfeiture proceedings and/or until further order from this Office. In this connection, please be guided by Customs Memorandum Order No. 8-84, particularly on the matter of making a return of service and submission of inventory of list of the subject articles.

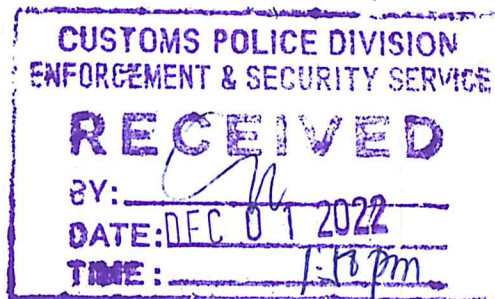
