## April 10-12, 2017 Report Port of Zamboanga

The Bureau of Customs, XIth Collection District has recorded a total of 102 importation entries during the week. (All informal entries).

Records also reveal that no balikbayan boxes was sent during the week and no auctioned shipments as well as shipments scheduled for auction was reported.

The port has also issued one (1) alert order and warrant of seizure and detention to an unknown claimant.

The apprehending team of this port was able to apprehend about 392 boxes of cigarettes with an estimate value of 3.8 million pesos.
