Port of Zamboanga

The Bureau of Customs XIth Collection district has recorded a total of 31 importation entries (3 formal and 14 informal entries) from April 1 to 7 2017. The export division of this port on the other hand, has recorded a total of 14 export entries during the same period bringing 31 in totality.

However, no entries were recorded for auctioned shipments as well shipments scheduled for auction. No Balikbayan boxes were also sent during the week.

This port has also issued an alert order and warrant of seizure and detention to an unknown claimant.

Moreover, about 392 boxes of cigarettes were seized by elements of this port with an estimated value of P3, 841,800.00.
