DIRECTING ALL GOVERNMENT AGENCIES AND INSTRUMENTALITIES, INCLUDING GOVERNMENT-OWNED OR -CONTROLLED CORPORATIONS, AND ENCOURAGING LOCAL GOVERNMENT UNITS, TO EXTEND SUPPORT TO THE 19<sup>TH</sup> ASIAN SENIOR WOMEN'S VOLLEYBALL CHAMPIONSHIP

**WHEREAS**, the Larong Volleyball sa Pilipinas, Inc. will host the 19<sup>th</sup> Asian Senior Women's Volleyball Championship 2017, which will be held from 09 to 17 August 2017 at Biñan, Laguna; and
