CUSTOMS MEMORANDUM CIRCULAR No. 105 - 2014


To: All Collectors of Customs Importers, Customs Brokers, Brokers' Representatives and All Others Concerned

In line with Customs Memorandum Order No. 15 - 2016, the Exchange Rate below duly issued by the Bangko Sentral ng Pilipinas on 03 August, 2016 shall be the applicable Rate of Exchange for the week August 4, 2016 – August 10, 2016 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
