CUSTOMS MEMORANDUM CIRCULAR No. <u>139 - 20/5</u>

To: All Collectors of Customs Importers, Customs Brokers, Brokers' Representatives and All Others Concerned

In line with Customs Memorandum Order No. 14 - 2002, the Exchange Rate below duly issued by the Bangko Sentral ng Pilipinas on 24 September, 2015 shall be the applicable Rate of Exchange for the week September 26, 2015 – October 2, 2015 for both the regular consumption entries (formal and informal), warehouse entries as well as withdrawal entries for shipments entered under warehousing.
